Summary: Essential Instructional Practices in Early Literacy (PreK):

All PreK teachers will implement the following ten essential practices into daily instruction with all students: 1) Intentional use of literacy artifacts in dramatic play and throughout the classroom, 2) Read aloud with reference to print, 3) Interactive read aloud with a comprehension and vocabulary focus, 4) Play with sounds inside words, 5) Brief, clear, explicit instruction in letter names, the sound(s) associated with the letters, and how letters are shaped and formed, 6) Interactions around writing, 7) Extended conversations, 8) Provision of abundant reading material in the classroom, 9) Ongoing observation and assessment of children's language and literacy development that informs their education, 10) Collaboration with families in promoting literacy.

Essential Instructional Practices in Early Literacy (K-3):

All teachers of ELA, grades K-3, will implement the following ten essential practices into daily instruction with all students: 1) Deliberate, research-informed efforts to foster literacy motivation and engagement within and across lessons, 2) Read alouds of age-appropriate books and other materials, print or digital, 3) Small group and individual instruction, using a variety of grouping strategies, most often with flexible groups formed and instruction targeted to children observed and assessed needs in specific aspects of literacy development, 4) Activities that build phonological awareness, 5) Explicit instruction in letter-sound relationships, 6) Research- and standards-aligned writing instruction, 7) Intentional and ambitious efforts to build vocabulary and content knowledge, 8) Abundant reading material and reading opportunities in the classroom, 9) Ongoing observation and assessment of children's language and literacy development that informs their education, 10) Collaboration with families in promoting literacy.

Essential Instructional Practices in Early Literacy:

The "Essential Instructional Practices in Early Literacy" were developed to increase the capacity of instructional staff to improve children's literacy through implementation of a small set (10) of research-supported instructional practices. The implementation focus is on classroom practices, rather than on school- or systems-level practices. Research suggests that each of these ten practices can have a positive impact on literacy development when practices are used in every classroom every day with every child. This Goal is an example that can be used when focusing on K-3 and working alongside the state-wide document, "Essential Instructional Practices in Early Literacy Grades K-3". There is a companion document for Prekindergarten and one for Grades 4-5 that can help buildings see the similarities between the ten essentials at PreK and upper elementary.
