



36 Michigan public school districts receive perfect Munetrix Scores for three consecutive years

Districts achieve ‘fiscal wellness’ amid difficult financial times

The perfect Munetrix Scores are for the 2016-2017, 2015-2016 and 2014-2015 school years and are based on the latest available audited school district data provided by the [Michigan Department of Education](#). The [Munetrix Score](#) range is zero to 10, with zero being a perfect score. Munetrix’s algorithms mash 12 critical data points over three-years while looking for chronic or high magnitude problems such as a tenuous fund balance or large enrollment swings. The Munetrix Score provides school leaders a robust fiscal early warning tool and allows them the ability to model financial plans into the future to see what their “wellness” will look like two to three years down the road.

“Based on their Munetrix Scores, these districts are to be commended for their fiscal stewardship,” Munetrix President Bob Kittle said. “At a time when all eyes are on the public sector to do more with less, school districts, with their precious cargo being children, are under even more optical scrutiny. The parents in these districts should take comfort knowing the boards and administrators hold fiscal sustainability close to their heart, which is especially important as Michigan’s overall student population continues to decline.”

Most Improved Districts

Kittle noted that three districts on the list, Montrose Community Schools, Oak Park School District and Reed City Area Public Schools, deserve ‘most improved’ status, since all three improved eight points over a three-year period and sustained a perfect Munetrix Score for two additional years.

“These three districts were in a financially precarious position just a few years ago and now are reflecting what we refer to as municipal wellness,” Kittle said. “It’s a plus for students, families, and the community that these districts have been able to turn around their financial woes to this degree. But key for Montrose, Oak Park, Reed City and all schools on the list is to continue monitoring and evaluating major financial decisions and their strategic plans. Each district has its own unique story, and a perfect wellness score doesn’t mean things are or will be easy for them in the future, even with Gov. Snyder’s proposed \$233 bump in per-pupil funding for next year.”
