I. FINANCIAL ISSUES:

1. Mr. Pierce reviewed the proposed 2014-2015 ISD budget.

2. Mr. Palmer reviewed the budget amendments with the board. This amendment projects the district using \$420,680 of the fund balance leaving an estimated ending fund balance of \$239,032 which is \$18, 290 higher than the prior amended budget.

- 3. Mr. Palmer informed the board that in 2014-2015 the district is not slated to receive Section 22j Performance-Based funding which we received this year (\$88,634). As of this date the State has yet to release their explanation for the loss of income. It is possible that our achievement levels have plateaued. No substantial increase means no funding but that is our best guess at this point.
- 4. Mr. Palmer updated the board on the 2014-2015 budget progress. Based on the latest Revenue Consensus held by the State they are projecting a \$1 billion shortfall for 2014-2015. We are not certain how this will effect State Aid. We hope the Governor will continue to give us the \$111 per pupil increase. Another scenario suggests a \$67 per pupil cut to State Aid. For future discussion Mr. Palmer would like the Board to consider looking at how much (%) they would like to see the fund balance increase per year.

J. CURRICULUM ISSUES:

 The Institute for Excellence in Education will provide Math curriculum training to our district through a contract with our ISD. This will partially fill the loss of Dr. Makas. They will train 1st -5th Grade staff countywide. The ISD will cover the cost of \$72,500 and the districts will pay the ISD \$5,000 for the training. The cost is covered under the Title II Part A grant.

2 The Support Staff Layoff list was determined by the results from the Committee at Central School who took a look at how their staff provided instruction and what the basic needs were that needed to be filled. Then administration looked at seniority lists and plugged in staff accordingly. It was decided to move from using Title I parapros to Title I classrooms. Moving Kindergarten to Central School save the district approximately \$63,000. It is still the plan.

N. OPERATIONAL ISSUES:

 Mr. Schuler informed the board that Meijer is donating a new baseball scoreboard to the district. Meijer will be advertising on the scoreboard and Cooks' GMC will donate \$1500 toward the installation. Mr. Schuler asked the board to allow Meijer to advertise on the scoreboard.

2. Mr. Wilkinson reviewed the current bussing situation. In the 12 years he has been with the district only 1 bus has been purchased. This year the district had to replace a motor and a transmission on a bus at a cost over \$13,500. We have 2 busses that are questionable at this point. To lease a propane bus the cost is \$14,800 per year for 3 years. The cost of the propane can be locked in at \$1.07/gallon at this time. The Federal Government will pay \$0.50/gallon for the fuel used as part of a green initiative. The lease allows for 15,000 miles annually. We put 14,000 on a bus.

MOTION by Randy Middlin, Ben Guile not to lease any propane busses at this time. MOTION CARRIED (unanimous)

3. Matt Lambertson informed the board that the E-911 phone compliance/network infrastructure bid obtained by the ISD was considerably higher than planned. So the district put out its own bid out to approximately 190 companies this week. The hope is for the bid to come in at about half the cost of the ISD bid. Mr. Lambertson is also looking into grant funding to help fund our technology needs.

Something new, Vassar students video-conferenced with Vassar graduates who have earned PhD's to get students to start thinking about life after graduation and college.
