BE IT FURTHER RESOLVED, the total revenues and unappropriated fund balances estimated to be available for appropriations in the Food Service Fund of the Vassar Public Schools for fiscal year 2013-2014 are as follows:

Changes in the amount appropriated by the Board shall require approval by the Board.

BE IT FURTHER RESOLVED, the Superintendent is hereby charged with general supervision of the execution of the budget adopted by the Board and shall hold department heads responsible for performance of their responsibilities within the amounts appropriated by the Board of Education and in keeping with the budgetary policy statement hitherto adopted by the Board.

This appropriation resolution shall take effect on the 1st day of July 2013 for the fiscal year and supersedes all other budget appropriations of the Board for the 2013-2014 fiscal year.
