RESOLVED, that this resolution shall be the general appropriations of Mid Peninsula School District for the fiscal year of 2017-2018 a resolution to make appropriations; to provide for the expenditure of the appropriations; and to provide for the disposition of all income received by the Mid Peninsula School District. The Mid Peninsula Board of Education plans to levy 18.00 mills for operating purposes against all non-homestead and non-qualified property in the school district.

BE IT FURTHER RESOLVED, the superintendent is hereby charged with general supervision of the execution of the budget adopted by the Board and shall hold the department heads responsible for the performance of their responsibilities with the amounts appropriated by the Board of Education and in keeping with the budgetary policy statement hitherto adopted by the Board.
