Philip Martin presented the 2016-2017 Budget Amendment. The Board discussed the Budget Amendment and reviewed corresponding drafts of Amended Appropriation Resolutions for approval.

Moved by Kevin Maurer and supported by Dave Harris to adopt the Amended General Fund Appropriation Resolution as submitted. Total fund revenues are budgeted at \$12,022,315 and fund expenditures are budgeted at \$12,211,029. Motion passed unanimously.

Moved by Karen Uebler and supported by Dave Harris to adopt the Amended Building and Site Fund Appropriation Resolution as submitted. Total fund revenues are budgeted at \$973,953 and fund expenditures are budgeted at \$899,500. Motion passed unanimously.

Moved by Dan Wortman and supported by Kevin Maurer to adopt the Amended Food Services Appropriation Resolution as submitted. Total fund revenues are budgeted at \$483,303 and fund expenditures are budgeted at \$482,301. Motion passed unanimously.

Moved by Dave Harris and supported by Karen Uebler to approve the Kuhn Specialty Flooring bid of \$156,900, to tear up and replace the FHS gymnasium floor. Motion passed unanimously.
