# Financial Matters

# Substitute Pay

Board Policy 3120.04 provides that the Board shall offer competitive compensation at a rate set annually in order to retain well-qualified substitutes for service in the District. Upon recommendation from Superintendent Martin and the review of substitute compensation rates offered in the area, it was moved by Dave Abke and supported by Amy McAvoy to continue the current rates of \$75 per day, and \$85 per day for long-term substitutes. Motion passed unanimously.

## Athletic Handbook

Upon recommendation from Phil Martin and Kevin Schwedler, it was moved by Karen Uebler and supported by Colin Maurer to approve certain changes to the 2019-2020 Athletic Handbook as submitted. Motion passed unanimously.
