CORRESPONDENCE

Superintendent Makowski shared a letter of appreciation from the Dominican Sister of Peace for the donation made in memory of Tracy Renkiewicz's grandmother. A thank you card and photos from the cross country team for school provided transportation was also shared.

BOARD INFORMATION REPORT

President Mike Vogt and Superintendent Makowski presented Mr. George Klein with a retirement gift, honoring him for his years of service as a JL bus driver.

The 2015-2016 Financial Audit was presented by Trina Edwards, CPA, MSA of Dennis, Garltand and Niergarth. General Fund revenues exceeded expenditures by \$34,533 leaving an ending fund balance of \$769,848.

BUDGET UPDATE

The year-to-date revenue and expense report for General Fund was provided. A budget report for the Sinking Fund revenue and expenses was also provided.

COMMITTEE REPORTS

Building and Grounds

The committee met to review quotes for repairs to staircases, window and door casings on the outdoor athletic buildings. The committee asked Mr. Sewell to move forward starting on the Spring athletic areas (baseball, softball, and track). Sinking Fund project SF 1.2 for 2017 was reviewed and discussed. A contract amendment for the architect and a summary of the project were reviewed.

Finance

The committee met to review options for Business Office services. We no longer have a contract for shared services with Wayland Union Schools following the retirement of Bill Melching. Superintendent Makowski presented a proposal for continued services with Mr. Melching as an employee beginning November 1, 2016.

Athletics

Committee met to review requests regarding Golf and Cheerleading. The golf club is seeking recognition as an MHSAA sport in order to participate in MHSAA sponsored events. A group of young women and a parent volunteer are asking to create a volunteer run cheer program. Cheerleaders would do sideline cheer at home events only beginning with basketball season. Both golf and cheerleading would be volunteer organizations, self-funded, and not on "track" to become a sport.

Principals

Mrs. Odren reported staff have begun student assessments with first and second grade early math and literacy benchmarks as well as the first of three annual Illuminate tests. Data Review meetings have begun to identify K-5 At-Risk students to form interventions.

Mrs. Kievit and Mr. Chrencik are in Traverse City at the High School Band Festival. Their reports are included in your packet.

Superintendent Makowski

Mrs. Makowski reviewed her upcoming calendar, reminding the board of the special meeting and workshop Wednesday, October 12, 2016. An update on the roofing projects was provided. The Lewiston building requires additional insulation but is nearing completion. The Johannesburg building had a leak over the Robotics room. The issue is being resolved quickly and professional by Sugar Construction. The administrators continue to work on the new teacher evaluation tool and staff training. The COPESD is looking to schedule board trainings on restorative justice for student discipline. When the training is available we will look at scheduling it along with standards based grading practices.

Tracy Renkiewicz thanked Mr. Claeys for the time and effort involved in organizing the first annual Military Appreciation football game. She announced the Veteran's Day program at JL will take place on Friday, November 11, 2016 beginning with breakfast at 8:30 am.

Summer Tax Resolution

Johannesburg-Lewiston Area Schools (the "District")

A regular meeting of the board of education (the "Board") of the District was held in the Lewiston Media Center in the District, on the 10^{th} day of October, at 6:05 o'clock in the evening.

The meeting was called to order by Michael Vogt, President.

The following preamble and resolution were offered by Member Huston and supported by Member Claeys.

WHEREAS, this Board previously adopted a resolution to impose a summer tax levy to collect 100% of annual school property taxes, including debt se1/ice, upon property located within the school district and continuing from year to year until specifically revoked by the Board.

NOW, THEREFORE, BEIT RESOLVED THAT:

- 1. This Board, pursuant to 1976 PA 451, as amended (the "Revised School Code"), hereby invokes for 2014 its previously adopted ongoing resolution imposing a summer tax levy of 100% of annual school property taxes, including debt service, upon property located within the District and continuing from year to year until specifically revoked by this Board and requests each city and/or township in which this District is located to collect those summer taxes.
- 2. The Superintendent or designee is authorized and directed to forward to the governing body of each city and/or township in which this District is located a copy of this Board's resolution imposing a summer property tax levy on an ongoing basis and a copy of this resolution requesting that each such city and/or township agree to collect the summer tax levy for 2014 in the amount as specified in this resolution. Such forwarding of the resolutions and the request to collect the summer tax levy shall be performed so that they are received by the appropriate governing bodies before January 1, 2014.

- Pursuant to and in accordance with Section 1613(1) of the Revised School Code, the Superintendent or designee is authorized and directed to negotiate on behalf of this District with the governing body of each city and/or township in which the District is located for the reasonable expenses for collection of the District's summer tax levy that the city and/or township may bill under MCLA 380.1611 or MCLA 380.1612. Any such proposed agreement shall be brought before the Board for its approval or disapproval.
- All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution be and the same are hereby rescinded.
