The AER addresses the complex reporting information required by federal and some requirements of state laws. Our staff is available to help you understand this information. Student Assessment Data

This includes the following three assessments: M-STEP (Michigan Student Test of Education Progress), MI-Access (Alternate Assessment), and College Board SAT. The report resents assessment information for English, language arts and mathematics for grades 3 to 8 and 11, and science for grades 4, 7, and 11, compared to state averages for all students as well as subgroups of students. The report helps users to understand achievement performance within grades and schools, and to make comparisons to district, state, and national achievement benchmarks.

The accountability portion of the AER includes assessments proficiency and participation rates, graduation or attendance rates, as well accountability scorecard status.

Teacher Qualification Data

This identifies teacher qualifications at district and state levels and reports the percentage of core academic classes taught by teachers not considered highly qualified to teach such classes.

All Quincy Community Schools teachers are highly qualified to teach the core academic classes.

This provides state results of the national assessment in mathematics and reading every other year in grades 4 and 8.

For the 2017-18 year, no new Priority or Focus schools were named in the district.

Our priority this year was to continue to create a culture of growth mindset. That every student can learn and we will reach every student. We now continually review our talent management (hiring), our performance management (student learning progress), and instructional practice of high quality instruction. This review directs to visit classrooms more frequently, look at the effectiveness of our student supports (counseling department), and review that we have high quality people at every position.
