

**RESOLUTION FOR ADOPTION BY THE BOARD OF EDUCATION

RESOLVED, that this resolution shall be the general appropriations of Uby Community Schools for the 2016 – 2017 fiscal year; a resolution to make appropriations; to provide for the expenditure of the appropriations; and to provide for the disposition of all revenue received by the Uby Community Schools.

BE IT FURTHER RESOLVED, that the total revenues and unappropriated fund balance estimated to be available for appropriation in the **Lunch Fund** of the school district for fiscal year 2015 – 2016 is as follows:

BE IT FURTHER RESOLVED, that the Superintendent is hereby charged with general supervision of the execution of the budgets adopted by the Board and shall hold the administrators responsible for performance of their responsibilities within the amounts appropriated by the Board of Education and in keeping with the budgetary policies of the Board.

The appropriation resolution is to take effect on June 27, 2016.
