



## Coleman Community Schools Return to Learn and Continuity of Services Plan 2024-2025

Coleman Community Schools will continue to prioritize full, in-person teaching and learning which provides the greatest benefit to students. Ensuring that this can happen both consistently and safely during the 2024-2025 school year. The Return to Learn Plan provides detailed guidance to ensure that COVID-19 prevention and mitigation measures are implemented in a way that fosters optimal learning environments while simultaneously ensuring the health and safety for students and staff in Midland County. This plan was developed by Coleman Community Schools and supported by guidance from the Midland County Health Department (MCHD) to ensure that our school district has a detailed a plan for a successful and safe return to school and learning environment.

*Please Note: This plan may change and evolve as knowledge changes surrounding current and potential variants or if the risks of severe disease, hospitalizations, or death increase. The plan may also need to vary based on in-school COVID-19 activity and outbreaks. If such changes are necessary, transition time may be needed to allow the district or building to adjust mitigation strategies. Periodically, but not more than every six months during the life of the grant, the plan will be reviewed, and updates will be completed, if deemed necessary.*

Based on the community COVID-19 level, in consultation with the MCHD, the District will determine the number of mitigation strategies to implement to foster optimal learning environments while simultaneously ensuring the health and safety of students and staff. Coleman Schools Superintendent and Nurse/HRA, along with the other Midland County Superintendents meet monthly or more frequently as situations require to discuss and develop on-going needs and plans for the health of students and staff.

<b>Remote/Virtual Learning</b>		
<p>The district is <b>currently piloting a virtual option for specific cases such as those who were already online or being homeschooled who can successfully receive services and find success, but must file an application and be pre-approved by the principal and superintendent with feedback from Coleman teachers</b>. Other options for remote/virtual learning will occur only as listed below. The district will do its best to provide resources for students who are unable to attend in person due to isolation or quarantine. If a classroom or school is closed, all students impacted by the closure may be provided remote learning opportunities throughout the closure. Per MCL 388.621f. Subsection 14, virtual days meeting the following requirements may be a part of the District's Continuity of Learning Plan and meet the hours of instruction:</p> <p><i>(14) Subject to the requirements in this subsection, a district may provide instruction under this section for not more than 15 days in a school year. If a district plans to provide instruction under this section to pupils for not more than 15 days during a school year, the district's plan must be approved by the board of the district and the district must provide notice of the plan to impacted pupils and their parents or legal guardians before enactment of the plan. Days of instruction under this subsection may only be used for the following purposes, as defined by the department:</i></p> <p><i>(a) Emergency closures.</i></p> <p><i>(b) Student testing days.</i></p> <p><i>(c) Professional development purposes, not to exceed a total of 30 hours during a school year.</i></p>

<p>Parents/Guardians are not to send children to school who are ill per PO 8450 - Control of Casual Contact Communicable Diseases. Students/ staff exhibiting the following symptoms that are new or different/worse from their baseline of any chronic illness shall remain home or excluded from school/ work or excluded from school/work until is symptom-free for 24 hours without the aid of medication or as indicated for their illness.
