WHEREAS Saginaw County's twelve public school districts and six public school academies will be the benefactors of a successful Saginaw ISD's special election millage election; and,

WHEREAS the annual funding shortage of \$283,000 in the Frankenmuth School District will be greatly reduced and hence benefit all students attending the Frankenmuth School District.

THEREFORE BE IT RESOLVED that the Frankenmuth School District Board of Education endorses the Saginaw ISD's August 2, 2022 Special Education Millage Election; and,

BE IT FURTHER RESOLVED that the Frankenmuth School District Board of Education will work to fully inform voters about this election, explain the benefits of a successful election for all students attending the Frankenmuth School District and encourage all voters in Saginaw County to support the Saginaw ISD's August 2, 2022 Special Education Millage Election.
