8. PRESENTATION

A. Business and Operations

1. Richmond Community Schools Hall of Honor/Fame Showcase

Preston Treend, Director of Athletics Facilities, and School Safety, and Susan Boyd, Richmond Education Foundation Board of Directors member, presented a proposal to the Board of Education to purchase an interactive *Hall of Honor* to showcase academic and athletic accomplishments in Richmond Community Schools. The *Hall of Honor* interactive system would be installed on the wall facing the high school cafeteria, located outside the northeast high school main gymnasium doors. Richmond Blue Devil academic and athletic graphics would cover the wall the interactive *Hall of Honor* is displayed on.

8. SUPERINTENDENT'S DISTRICT AND LEGISLATIVE UPDATE

Superintendent Walmsley reported there was no public comment to respond to at the February 13, 2023 Board meeting.

Legislative Update:

Prevailing Wage Law Headed to Governor

On Tuesday, the Legislature passed <u>House Bill 4007</u> to reinstate the prevailing wage law that was repealed in 2018. This was a priority of the Democrats when they took the majority, and the bill is now headed to the Governor. The Governor has signed.

During debate in the Senate, we were successful in getting an amendment to grandfather in current bonded projects. The language states that school projects funded with revenue from millages authorized before the effective date of the act would not be subject to the act. The new act will go into effect 90 days after the legislature adjourns for the year.

House Passes Repeal of A-F Ranking System

On Tuesday, the House Education Committee approved <u>House Bill 4166</u>, which would repeal Section 1280g of the Revised School Code, known as the A-F rating system for schools. This system does not meet federal requirements for an accountability system and is redundant to the system Michigan uses to meet those requirements.

After approval by the committee in the morning, it was passed by the full House in the afternoon by a vote of 63-45. It is now under consideration by the Senate Education Committee.

Senate Education Committee Approves License Reciprocity

On Tuesday, the Senate Education Committee approved a pair of bills aimed at reciprocity for certain licenses between states. <u>Senate Bill 161</u> would allow for reciprocity of a person's teaching certificate from another state, country or Federally-recognized Indian tribe. <u>Senate Bill 162</u> would do the same for school counselors. They are now before the full Senate for consideration.

Upon approval from the Board tonight, the technology will be purchased, and installation will begin this summer.

Board member Pacitto motioned to accept the recommendation of the Superintendent and approve the contract with Digital Age Technologies (DAT) for the purchase of classroom interactive technology for the middle school and high school for a total not to exceed \$191,182.00 for which funding from the FY2023 General Fund is authorized as outlined in the attached documentation. She stated that the REA leadership turned down the district offer. She stated that the REA provided two offers and none of these offers were acceptable by the district. She stated that the offer by the district would allow Mr. Walmsley to put a new teacher above teachers that have been here for 15 or more years.
- Scott Goode addressed the Board regarding his son, Connor, who was threatened by the student at the Middle School with the knife. He stated he is not happy that the student that threatened his son is back in school. He stated that the student should have had more time away from school than he did.
- Kristina Turchi addressed the Board regarding her hesitation on sending her student to school today. She stated she asked what the safety plan is with her students returning to school. She stated the school refused to tell her how the district was planning on keeping the students safe. She stated she wants answers on how they are keeping the students safe.
