- The "Show your love for PACE" campaign was a great success. We asked teachers, staff, students, and parents about their experiences at PACE.
 Presented videos of teacher, student, and parent interviews.
- Monthly Teacher highlights: 6th grade team, Mrs. Butler-Dickerson, Mrs. Pullins, and Ms. Pritchard.
- Completed Teacher Mid-Year Evaluations, which include demonstrating knowledge of content and pedagogy, setting instructional outcomes, establishing a culture for learning, managing classroom procedures, using questioning and discussion techniques, and engaging students in learning.
- GSRP Formed a school-based committee to lead the Great Start Readiness Program (GSRP) initiative. Currently seeking board approval for a resolution to amend the charter agreement. We are working on classroom licensing to meet GSRP requirements. Met with Ms. Jones from Teachers First; she has experience opening GSRP programs in other school districts. Attended a childcare licensing overview on February 18th.
- School Happenings: Student Awards Ceremony, Varsity & JV Basketball Season, and Weekly Communications.
- Operations Update: On February 3rd, we started re-enrollment and sibling enrollment. March 3rd begins Open Enrollment. In April and May, we will have Kindergarten Round-Ups.
