MUNETRIX SUBSCRIPTION AGREEMENT - THE CHARTER TOWNSHIP OF BLOOMFIELD

Thank you for your willingness to make an investment in Munetrix. This letter and attachments will act as the Subscription Agreement ("Agreement") and to memorialize the terms to Munetrix's products and services under the Agreement.

Munetrix LLC agrees to license The Charter Township of Bloomfield to access and use the MUNETRIX online software data, planning and analytics solutions ("the Product") for the purpose and business related to The Charter Township of Bloomfield under the following, revised terms for our **Premium Edition**.

- 1. The Charter Township of Bloomfield's Subscription Agreement will last for a term of three years commencing on the first day of the next month from the date of your signature below. (Jan. 1, 2018).
- 2. Except as provided for under Paragraph 4, The Charter Township of Bloomfield agrees to pay an Annual Subscription Fee of \$6,844.35 for each year of the term, with each annual license fee being due and payable as set forth in this Agreement. For Bloomfield Township, the implementation fee is waived, leaving the first year total fee at \$6,844.35 for the Premium Edition. The Charter Township of Bloomfield's purchase of this Subscription Agreement to MUNETRIX entitles The Charter Township of Bloomfield to two Authorized User Accounts, which will be activated upon receipt of this Agreement signed by you or another Authorized Signatory of The Charter Township of Bloomfield.
- 3. The annual Subscription fee is based on The Charter Township of Bloomfield's 2016 US CENSUS population estimate of 41,258 and a formula provided to the Michigan Department of Treasury. Specific product options are outlined on the Services Proposal Worksheet, and are subject to the following terms:
 - a. Fee payable within 30 days of the date of your signature below.
 - b. Subsequent annual Subscription fees are due and payable on the first and second anniversary dates, as outlined in Paragraph 1.
- 4. If the State of Michigan does not adopt a reimbursement program of any type for subsequent fiscal years for Michigan Municipalities to license and use data analytics software, The Charter Township of Bloomfield shall have the option to terminate this Agreement upon written notice to MUNETRIX if done so before 30 days of the Anniversary Date. Such notice will eliminate any further contractual obligations by The Charter Township of Bloomfield to
- MUNETRIX. If The Charter Township of Bloomfield does not exercise this conditional early termination option, The Charter Township of Bloomfield will be obligated to pay the Subscription fees for subsequent renewal terms, due and payable on the first and second anniversary dates of the date of your signature below, as explained above.
- 5. This Agreement entitles The Charter Township of Bloomfield to two Authorized User Accounts for named and registered users who must also agree to the MUNETRIX Terms of Use, which are available at Munetrix.com. COMPANY AND LICENSEE RESPONSIBILITIES

Licensee and User Responsibilities: The Licensee and User shall (i) be responsible for the accuracy, quality and legality of its data entered into the Tool (or any database that utilizes the Tool) and of the means by which such data is acquired, (ii) use commercially reasonable efforts to prevent unauthorized access to or use of the Tool, and notify the Company promptly of any such unauthorized access or use, and (iii) use the Tool only in accordance with the Terms of Use and applicable laws and regulations.

This data will be labeled as "Historic" and subsequently be "locked down" so no further editing is allowed. Basic system enhancements will occur periodically at no additional charge. These updates will be in the form of slight modifications that make the system more user- friendly or intuitive, and may include various additions to data or charts that can help a municipality or the general public understand the data better. No version downloads are required by the Licensee; these updates will automatically appear once released for production and a User Notification will appear upon the Licensees next log-in. The Notification feature is TURNED ON as the Tool's default setting, and this preference may be changed by the Licensee using the system's settings. The company will also respect the privacy of Licensees (the Munetrix Privacy Policy is available at Munetrix.com).

Limitation of Liability: The liability of the Company arising out of or related to this Agreement or the Tool shall not exceed the amount of the most recent Subscription Fee paid by the Licensee under this Agreement. Relationship of the Parties: The parties to this Agreement are independent contractors. This Agreement does not create a partnership, franchise, joint venture, agency, fiduciary or employment relationship between the parties.

State of Michigan Reimbursement: Reimbursement by the State of Michigan to the subscribing local unit under Section 936 of the 2017-2018 General Government Appropriations will be made to the local unit upon their request for reimbursement to the Michigan Department of Treasury, per the Legislation. Munetrix, to the extent permitted, will prepare the documentation on behalf of the subscribing local unit, but submission and confirmation of receipt will be the responsibility of the subscribing local unit.

Governing Law: This Agreement shall be bound by the laws of the State of Michigan.

Entire Agreement: This Agreement along with the Terms of Use constitutes the entire agreement and supersedes all prior agreements, proposals or representations, written or oral. No modification, amendment, or waiver of anyprovision of this Agreement shall be effective unless in writing and signed by the party against whom themodification, amendment or waiver is to be asserted.
